ii. Consideration of Proposal by UGA Extension Office & Master Gardeners' Club

1. Call to Order

2. Approval of Previous Minutes

The February 12, 2020 minutes were approved. Motioned by Steve Pressley, seconded by Mark Preetorious. Motioned carried 3-0.

3. Appearances / Public Comment

Julie Marankie along with other residents with Allatoona Landing subdivision was present to discuss park improvements at Field's Landing Park. Mrs. Marankie discussed with the board that she has been a resident of Cherokee County for 24 years and the reason for locating to the area was access to the lake. The board thanked her for coming to the meeting and they also informed Mrs. Marankie she will be kept informed of the improvements that are made at Field's Landing Park.

4. Reports/Board Business

a. Chairman

Chairman Nelms informed the board of the passing of Amy Turcotte's brother. He asked for everyone to keep Amy and her family in our thoughts and prayers.

b. Board Members

Mark Preetorious spoke with the board about the joining of Rope Mill, Blankets Creek and Falls of Allatoona trail systems. He informed them about the demand for Rope Mill/Blankets Creek connection need for access to the Falls of Allatoona avoiding any private property confrontations. The need for trash/litter collection to avoid infiltration to Lake Allatoona, increased police and DNR presence and visibility. Mr. Preetorious resolution would be to secure land from the Corp of Engineers for bike trail linkage and spur trail from the Aquatic Center to the Falls. SORBA has to maintain the bike trails. Construct proper trailheads and delineated trail spur to Falls. Provide trail directional warning signs, trash/litter collection through either County Parks and Recreation or Corp process. There was discussion from the board that the Corp does not want to give up the land and the Corp's focus is on the campground. They also talked about where trail systems prioritized in the master plan and how the staff has viewed it. There would be some challenges to join the trails; however, trails are in the master plan. Mr. Preetorious stated to the board he was not looking for a motion, but that he only wanted to make them aware of this matter. The board encouraged Mr. Preetorious to schedule a meeting with Jay Worley, CRPD Director and Bryan Reynolds, CSA Director to further discuss the trail systems.

c. Director

Director Worley stated there were 18 people present for the advisory board meeting. He also gave the board an update on information that has been going on since the last meeting and the Coronavirus/COVID-19 pandemic. Director Worley also started by introducing CRPD newest staff: Matthew Grantey, Athletic Coordinator – CYB Jarron Amburgey, Recreation Coordinator - TR and Bailey Barcomb, Recreation Coordinator – Marketing Coordinator.

i. Agency Update

- Aquatic Center's Oasis will reopen on June 15
- Interviews are completed and an offer has been made to for the Aquatic Center's Coordinator's position
- Adventure Express summer day camp, adult softball leagues and a few recreation baseball teams have started back
- The recreation division has done an excellent job with handling the first week of camp, the athletic division is working to get more leagues opened, and the administrative division has done a great job in getting the building and office ready for the reopening.
- USA Olympics softball team tournament will be rescheduled in 2021
- LB Ahrens Recreation Center will go out to bid in July, and the business plan is being worked on
- Brian Walker fields has been top soiled and there has been an expansion of the parking lot
- An architect will be drawing up a master plan for the southwest project near Clark Creek
- Garland Mountain is requesting some maintenance. There has been some trees cut down. They have a lot of land and trails to develop
- Blankets Creek – added new gravel and mulch in the common areas and parking lot

5. New Business

a. Consideration of Proposal for the CRPA Strategic Plan 2020-2024

Director Worley presented and discussed the Strategic Plan 2020-2024 Power point with the Board. He highlighted the 2019-2020 milestones, the charge, stakeholders and the five (5) priority areas: the goals, actions and key performance measures. The board asked what was the difference between the state and the national accreditation. They were informed there is not a state level accreditation only on the national level. There is only around 11 public recreation and parks departments that are accredited in the state of Georgia. The CAPRA host site visit is in April 2021. Chairman Nelms informed the staff if the CAPRA is passed that there would be a lunch treat available. Motioned by Steve Pressley, seconded by Mark Preetorius. Motioned for consideration of proposal for the CRPA Strategic Plan 2020-2024 carried 3-0.

b. Consideration of Proposal for Buffington Park Development Concept Plan

Jordan Wood conducted a Cherokee County dog park proposal PowerPoint with the board. The proposed dog park at Buffington will feature two (2) fenced enclosures separating the larger dogs from the small dogs with a gravel parking area for approximately 16 vehicles. He also informed the board, after hearing from numerous citizen the need for a dog park in this area of the county and the

dog park would be a good fit. This would offer ample time for dogs to be off their leash and the citizens to be able to socialize as well. There is a Brewery opening next door, which could become a potential partnership. Motioned by Mark Preetorius, seconded Steve Pressley. Motioned carried 3-0.

c. Consideration for Proposal updated Athletic Field Use Policy

Shawn Schumacher discussed and presented a power point with the board about the consideration of a proposal updated athletic field use policy. He informed them about the current field use policy in addition, the priority users, each category and their cost. Shawn Schumacher stated these prices would remain through August 1, 2020 for category, 4 and the prices will change for categories 2 and 3 January 1, 2021. The pricing change for the new non-resident boat ramp fees would be effective January 2021. Daily fees for park goers will provide ID to park attendant to verify residence, when the attendant is not on duty park goers will use the honor system. Annual passes – a complementary annual passes for seniors are granted only at the Cherokee Recreation Center. All other passes can be purchase at either the Recreation Center or through the attendant on duty. Signage will be displayed at the park entrances and honor boxes. The battle was part of a larger campaign of the Cherokee against the Muscogee Creek people. They had 500 warriors led by Oconostota. After their victory, the Cherokees pushed the Muscogee people south from their northern Georgia homelands and began settling in the region. During the war, a Cherokee warrior named Kingfisher was killed and his wife joined the battle and led Cherokee to victory. Wilson's Bottom comes from the American comedian and actor Clerow "Flip" Wilson, Jr. The board had a discussion about what name would be most appropriate for the Hwy. 372 property "Long Swamp Outdoor Recreation Area". The board also had some questions for Adam Fussell. They wanted to make sure that there is signage in the park that will tell of the historic and significant meaning of the park. 3. FY20 Update – Cherokee Recreation and Parks has a \$5.6 million dollar budget, and had to shut down for 3 months when Covid hit. Once the numbers are all reported, it tentatively looks like there will be around only a \$33,500 in the red after 3 months of shutdown
4. Since Opening CCAC our staff have trained over 500 Lifeguards
5. CCAC won the GRPA Winter Lifeguard Competition 2020 (Finished 1st and 2nd) (see PPT)

c. Consideration of Proposal for Cline Park Splash Pad- Non-Resident Fees

Kim Whatley addressed the board about considering the proposal for Cline Park Splash Pad – Non-Resident Fees. She spoke with the board about the current expenses and the cost to operate the splash pad per day. The new expenses are due to the change in charging a daily fee and to purchase equipment needed for the staff on duty. The current revenue covers the staff, chemicals and use of the pavilion to run after the normal hours. When the staff is observing the non-resident users are from Bartow, Gilmer and Pickens counties, and the recommend change of a daily rate of \$1 for Cherokee County Residents and \$2 for Non-County Residents. Summer Pass – Individual Resident \$20, Non-Resident \$35 and Family Resident \$75 (up to 4 members), \$ 100 – Non Resident. Kim talked about the potential revenue with fee structure, and the marketing roll out to the community with pertinent information, special pass sale days prior to the season opening done at Cline Park and 10% discount on those days. Motioned by Mark Preetorious, seconded by Steve Pressley to approve the updates on the Cline Park Splash Pad – Non-Resident Fees. Motioned carried 4-0.
