1. Call to Order

Vice Chairman Carbetta called the meeting to order at 6:16 p.m. Present: Vice Chairman Carbetta, Steve Pressley 2nd Vice Chairman, Amy Turcotte, Chairman White, Director Reynolds and CRPA Staff. Absent: Jason Nelms

2. Approval of Previous Minutes

The April 10, 2019 minutes were approved. Motion Steve Pressley, seconded by Amy Turcotte. Motion carried 3–0.

3. Appearances / Public Comment

Dolores Guilfoyle, Linda Kimbell, Betty Owen, and Fran Saling were present to discuss the recreation center that will be located at Veterans Park and another Dog Park in the county. Ms. Saling addressed the board, and she stated that the group was thrilled to know that the recreation center was going to have an enclosed pool. Ms. Saling said, especially as you age, for anyone over 55 that a 30 minute water workout is very healthy and beneficial. She explained that she understand budgetary constraint, however she asked the board if they would consider the Aquatic Center becoming phase 2, and if it be completed as soon as possible. She also had concerns about the women locker rooms. The board members told Ms. Saling they appreciated her comments, and they will take all of them into consideration. Ms. Kimbell asked the board when will there be another dog park built in the County. She told the board the nearest Dog Park is located at Patriots Park and from the City of Canton. It takes 30 minutes to get there. After a discussion about the dog park, Director Reynolds stated there is still some undeveloped land at Veterans Park that could be cleared and used for another dog park.

i. Agency Update

Director Reynolds asked the board members to modify the agenda, in order to give the agency update and present concept plans for LB Ahrens Recreation Center at Cherokee Veterans Park.

This modification should help to answer some of the questions the public may have.

He informed the board of the following information:

- The tennis courts at Cherokee County Tennis Center are being resurfaced.
- The county has held the pre-bid meeting for a pavilion at Veteran's Park near the tennis and pickleball courts.
- The county is working on a project to convert the natatorium lights at the Cherokee County Aquatic Center to LED.

- The county has entered an agreement with Cherokee Soccer to develop Bryan Walker Field on Hickory Road into a practice facility.
- The spring programs have concluded and the summer programs have begun. The Adventures Express Summer Camp has added another location. Holly Springs Elementary is the second location.
- The new 3-on-3 CYB summer league program started games on June 10.
- The CCAC has new Cabanas available to rent.
- The CCAC will host the GRPA state swim meet July 19 – 20, and swimmers will be coming from all over the state of Georgia to compete.
- The Youth Sports Day recognition and ice cream social will held on August 20 at the Cherokee County BOC meeting.
- Sammy Long will be retiring after 12 years of working for Cherokee County. Sammy's last day will be Friday, June 21, 2019.

ii. Present Concept Plans for LB Ahrens Recreation Center @ Cherokee Veterans Park

Director Reynolds presented concept plans for LB Ahrens Recreation Center to the advisory board and the public in attendance at the meeting. He informed the board the facility will be built in 3 phases with the first phase being the Recreation Center. Director Reynolds gave a description of what the exterior of the facility will look like, and the amenities and services that will be available at the Recreation Center. He discussed the reasons why the three phases are being built in this order. There was a survey conducted on what the recreational needs were in the County, and the survey highest ranking was to have more basketball courts, the Aquatic Center is the most expensive phase in addition to no sewer line available currently at the park. Director Reynolds updated the board on the GDOT study and the expansion of Highway 20 at the entrance of Veterans Park.

5. New Business

a. Consideration of a Rule Banning Underwater Breath Holding at CCAC

Director Reynolds turn the podium over to Kim Whatley, CCAC Division Director to answer any questions the board may have on the consideration of a rule banning underwater breath holding at CCAC.

Proposed Rule:

Competitive breath holding is prohibited. This includes swimming drills that would have swimmers attempt to swim the length of the pool underwater holding their breath.

What can occur during this activity?

Shallow-water blackout occurs when a person tries to swim underwater for an extraordinarily long time, typically to build endurance. Swimmers often start by taking multiple deep breaths to go a longer distance underwater, causing their blood levels of carbon dioxide to plunge. Once underwater, carbon dioxide levels fail to rise quickly enough to signal the brain to breathe, oxygen levels fall rapidly, and the swimmer faints underwater and drowns.

Why have the policy?

Many coaches trained using these drills in the past when they were competitive swimmers. Therefore, they do not always understand the hazards that it poses even to well-trained swimmers. Most of the

swimmers at the Cherokee County Aquatic Center are not elite national swimmers and do not have the physical ability to participate in these drills.

Kim Whatley stated to the board she would like to see line 1 added our rules that underwater breath holding is not allowed. Motion by Vice Chairman Carbetta to approve the Rule Banning Underwater Breath Holding at CCAC. Seconded by Steve Pressley. The motion carried 3–0.

6. Old Business

a. Consideration of CRPA Mission, Vision & Values

Director Reynolds told the board there have been no changes made to CRPA's Mission, Vision and Values since they last reviewed the statement. By approving the Mission, Vision & Values statement, this will formally adopt the statement. The approval will meet one of the standards for the Agency's accreditation. Community Services Agency Director Reynolds updated the board on the following:

- **GRPA Awards**

In October & November, Cherokee County received several awards from the Georgia Recreation & Parks Association (GRPA). Cherokee Youth Basketball (CYB) was recognized as the GRPA District 5 Most Outstanding Program. CCAC Water Safety Week was recognized as the GRPA State Aquatics Outstanding Special Event. Vicki Kelley, with the Cherokee County Aquatic Center was recognized as the GRPA District 5 Outstanding Administrative Support Staff. Frankie Sanders, CRPA Recreation Programs Division Director, received the award as GRPA District 5 Outstanding Programmer. Finally, For the 6th time overall and the 3rd time since 2013, Cherokee County was recognized as GRPA District 5 Class A Agency of the Year, the top public recreation and parks agency in northwest Georgia. Judging for this award considers all the accomplishments over past twelve months including:

- contributions to the community through programs and special events,
- the involvement of staff in community organizations,
- the continued commitment to professional development of the staff,

- efforts made to promote the field of recreation,
- and other accomplishments with lasting impacts to the community such as partnerships and capital improvements.

Agencies are only eligible to win this award once every three years. So, Cherokee is honored to have received it each year we have been eligible since 2013.

Also recognized at the GRPA statewide conference on recreation last month were Kim Whatley and Jordan Wood as graduates of the GRPA Leadership II program and Jay Worley with a service pin for 20 years of service to GRPA. Finally, Robert and Tracie Strozier were recognized as GRPA Volunteers of the Year for more than 16 years of service to the Cherokee County Miracle League.

- **Great Pumpkin Festival**

The 2nd annual event was held November 2nd at Cherokee Veterans Park. Perfect fall weather. Very well attended. Briefly ran out of parking spaces. Vendors, pumpkin games (chunkin', bowling, etc.), face painting, food, helicopter rides, hay rides, bounce houses, petting zoo, live performances from our dance/gymnastics classes, etc.

ii. Consideration of Update to County Ordinances Related to “Air Vehicles”

Community Services Agency Director Reynolds discussed with the board the consideration of update to county ordinances related to “Air Vehicles.” In order to properly address requests/instances where individuals are using public parks to launch and land hot air balloons, paramotors, etc. the following changes to the county ordinances are recommended by the county attorney.

Sec. 42-55. – Use of engine-powered models, air vehicles, toys, and unmanned aerial systems.

(a) It shall be unlawful for any person to start, takeoff, or land any fuel-powered engine, jet-type, or electric powered model aircraft, boat, or rocket or like powered toy or unmanned aerial system, except at those areas designated by the County for such use and then only in accordance with such rules, regulations and restrictions established by the Director or the Director's authorized agent. Furthermore, such permission, when issued, shall be subject to all applicable Federal Aviation Administration (FAA) regulations.

(b) “Air vehicle” means any vehicle that is used or intended to be used for manned operation in the air. The term includes paramotors, ultralight aircraft, hot air balloons, airplane, ultra-light paramotor (paraglider) or any descent in or from any hot air balloon, airplane, paramotor (paraglider) hand gliders, and similar vehicles.

(i) No person shall make any ascent or descent in any air vehicle, including, but not limited to parachute landings, on any County-owned property, except unless they are part of an event sponsored by the County, given specific written permission by the County, or unless required for an emergency landing.

(ii) Any person operating an air vehicle or remote-controlled unmanned aircraft from County Property shall do so in accordance with all applicable, federal, state, and local laws, regulations, ordinances, and guidelines.

Motion made by Vice Chairman Preetorious, seconded by Steve Pressley to approve the update to County Ordinances Related to "Air Vehicles" with the final language to be determined by the county attorney. Motioned carried 4-0.

iii. **FY19 Annual Report Review and Approval**

Community Services Agency Director Reynolds summarized the FY19 Annual Report review with the board. Chairman Nelms and the board commended and praised Community Services Agency Director Reynolds on a job well done and wished him all the best in his new position, and they congratulated Director Worley as his successor. Motion made by Carlos Carbetta, seconded by Vice Chairman Preetorious to approved the FY19 Annual Report. Motion carried 4-0.
