Process for Obtaining Motorized Cart Registration

- Review the Motorized Cart Ordinance for Cherokee County, Georgia. A copy of the ordinance may be found by visiting the following link:

 - In addition, a copy may also be requested by contacting by contacting the County Office at (678) 493-6000.
- Complete the Motorized Cart Registration application and turn it in to County Development Services Staff, along with the applicable registration fee, at the Cherokee County Admin Complex located at 1130 Bluffs Parkway, Canton, GA 30114. As with other County permits, you may pay by credit card, check or cash.
- Complete the Motorized Cart Equipment Affidavit to confirm that the cart is in compliance with the terms of the Motorized Cart Ordinance and that the cart has the required safety features. (Notary on site.)
- Once all paperwork is completed and approved, you will be issued two registration decals to be affixed on each side of the cart before operating. The decals will display your registration number.
- Your permit will be valid through December 31st of the year marked on your permit. A one year, three year, or five year permit can be purchased at each renewal.

Motorized Cart Equipment Affidavit

All motorized carts shall have the following equipment affixed and in good working order per O.C.G.A. § 40-6-330.1: (*Please initial each requirement*) A braking system for the weight and passenger capacity of the vehicle, including a parking brake; A reverse warning device functional at all times when the directional control is in the reverse position; A main power switch. When the switch is in the "off position," or the key or other device that activates the switch is removed, the motive power circuit shall be inoperative. If the switch uses a key, it shall be removable only in the "off" position; Head lamps and tail lamps Reflex reflectors A horn A rearview mirror Safety warning labels Hip restraints and hand holds In addition to the equipment required above, gasoline operated motorized carts shall have the following equipment affixed and in good working order: An exhaust system, meeting the following specification: The exhaust system shall include the piping leading from the flange of the manifold to 1. and including the muffler and exhaust pipes and shall include any and all parts specified by the manufacturer 2. The exhaust and its elements shall be securely fastened The engine and powered mechanism shall be so equipped, adjusted and tuned as to 3. prevent the escape of excessive smoke or fumes. All motorized carts will have stickers affixed to the back lower left portion of each side of the cart, or in a location that is easily visible by the public. See attached photo on next page. If the motorized cart is sold, destroyed, or no longer owned by you, you will need to remove the decals and dispose of them. This will ensure the registration does not come back to you in case an incident occurs that requires the cart owner to be held liable for violations and/or damages.
